From the Castle Hill area of Buda to the imposing Parliament buildings in Pest, the city offers a wealth of museums, galleries, churches, synagogues, palaces, and historic buildings. In recent years, the lively café scene that animated Budapest in the early 20th century has been revitalized. A casual stroll through the city reveals a multitude of wonderful cafés and restaurants, especially in the increasing number of pedestrian zones. Many of the city's renowned theaters have been renovated over the past few years as well, including the Operetta Theatre and Thalia Theatre. It is not entirely surprising that Hungary's first president after the fall of the Soviet Union, Vaclav Havel, was a playwright. The cultural life of Budapest would be inconceivable without theater. Please join us on our getaway to beautiful and iconic Budapest!

Itinerary:

Day 1 April 16, 2018 - Depart the U. S. for Budapest, Hungary.

Day 2: April 17 - Arrival in Budapest. Welcome to Budapest. Upon arrival, proceed to baggage claim and after clearing customs, look for your guide who will be holding a W&L sign at the exit. After a private transfer to your hotel, the remainder of the day is at leisure. In the evening, we will gather for a welcome reception and dinner at the hotel or in a nearby local restaurant. Overnight in Budapest. (D)

Day 3: April 18 - Full Day Tour of Budapest. After breakfast and our first lecture, we begin our full day tour of Budapest focusing on the city's many highlights. We'll begin our discovery at Heroes' Square, a UNESCO World Heritage site, for the intriguing statues and historical buildings. We'll then, proceed to Andrássy Avenue to enjoy stunning views of the Opera House and St. Stephen's Basilica en route to the iconic Hungarian Parliament for an interior visit. Dramatically situated on the bank of the Danube River on Kossuth Lajos Square, the Parliament buildings dominate the Budapest skyline. Construction began in 1885 and was completed in 1904. Built in the Gothic Revival style, the enormous structure was designed by Imre Steindl, whose plan won an international competition held by the Hungarian government. The immense scope of the project required 40 million bricks, half a million precious stones, and 88 lbs. of gold-leaf. Steindl apparently went blind before his grand vision could be completed. The building contains many items of interest, including frescoes (the Hungarian Coronation Regalia with its Renaissance sword), mythical eagles, and an impressive staircase. Thereafter, lunch will be on your own at one of the many cafes that made Budapest famous. We then resume our tour and cross the Danube to delve into the gothic history of Buda Castle, another UNESCO World Heritage site. Castle Hill, or, as the locals call it, Castle Mountain has witnessed many of the most important historical events of Hungary. It preserves such artifacts as ancient stones and underground labyrinths, to lovely medieval houses and hidden gardens. During the tour, we'll stroll around the area while enjoying entertaining commentaries on the history and culture of the city of Buda and medieval Hungary. We'll study the ancient buildings on Buda's promenade, ascend the steep steps of Castle Garden to reach the resplendent Royal Palace, and then behold panoramic vistas of the glittering riverside from a vertiginous vantage point atop C

Day 4: April 19 - Discover Budapest and its Museums. After breakfast and our second lecture at the Hotel, we depart with our guide for a day dedicated to museum visits! Our guide and private coach will be at our disposal for the full day. A "Budapest Card" will be given to all group members to enjoy several included museums and attractions throughout the city. Later, the group will convene for a refreshment at the Café Gerbeaud, one of the greatest and most traditional coffee houses in Europe. The Café looks back to more than 150 years of history. Gerbeaud's specialties include famous cakes, such as Esterházy and Dobos cakes, as well as all kinds of cream cakes and extravagant baked goods. We'll take some time here for a nice treat while "people watching" from the terrace. Evening on your own. Overnight in Budapest. (B, Refreshment-coffee and cake)

Day 5: April 20 - Free Day in Budapest. Following breakfast in the hotel, enjoy a day at leisure to visit any of the wonderful museums and attractions with the "Budapest Card" or take advantage of the city's popular baths and spas. Overnight in Budapest. (B)

Day 6: April 21 - Full Day Trip to Danube Bend. After breakfast at the hotel, we'll depart to Esztergom for an interior visit of the town's famous basilica, the largest building in Hungary, dedicated to the Saint Mary of the Assumption and Saint Adalbert. It was built by Stephen I of Hungary between 1001–1010 as the original Saint Adalbert Church. In 1820, the Archbishop Sándor Rudnay restored Esztergom's status as the mother church of the country. The church maintains the relics of Catholic martyr and Saint Marko Krizin. We then continue to the Bodor Major, a 125-acre horse farm and leisure park on the Szentendre Island, situated 30 kms from Budapest. Upon arrival, we'll be greeted by live gypsy music, lángos bread, and Pálinka! We'll then enjoy a horse drawn carriage ride and discover life on the farm, including the making of peasant bread (kneading), cooking goulash in a cauldron (including a tasting along with the famous recipe), and a wine tasting. All are part of a typical Hungarian farmers' family business. Our farewell lunch at Kemencés Inn features gypsy music, goulash soup with the fresh baked peasant bread, mixed strudels, and wine along with a "Wrangler horse" show will round out our visit. If time permits, we'll make a short visit to the Baroque artists' village of Szentendre. Return to the hotel for a final evening at leisure. Overnight in Budapest. (B, L)

Day 7 April 22 - Return to the USA: After breakfast, check out and transfer to the airport for your flight back home. (Breakfast)
