- Enjoy seven nights at a luxurious, family-owned property overlooking the ancient Provençal hill village of Bonnieux.

Day-by-Day Itinerary*:

Day 1-2: En Route from U.S. / Arrive Marseille

Arrive in Marseille today and transfer to our beautiful accommodations, Domaine de Capelongue in Bonnieux. Perched on the slopes of the Petit Luberon mountains, Bonnieux is one of Provence's historic villages perchés, built atop rocky crags with fantastic views of the region. Within walking distance of the property are narrow streets, stairways, and medieval curving passageways that beckon you to explore. Tonight, in the restaurant recognized with two stars from Guide Michelin, the best-known guide to European dining, enjoy your first dinner prepared by Edouard Loubet's culinary team.

Overnight: Domaine de Capelongue (D)

Day 3: Bonnieux

Awaken your senses in a French kitchen. Your chef will enlighten you on his specialty: enhancing local, seasonal foods with inventive sauces and herbs. Break for lunch and savor your creation before another expertly instructed

lesson this afternoon on creating delicate desserts. This evening, enjoy time to relax, and perhaps take a short stroll to Bonnieux for dinner on your own. Overnight: Domaine de Capelongue (B,L)

Day 4: Gordes / Pont du Gard

Take in Gordes, one of the most beautiful hilltop villages in France on the way to the Roman-built Pont du Gard, part of an aqueduct built over 2,000 years ago. Journey back through time as you meander through the aqueduct's museum that holds life-sized reconstructions. Overnight: Domaine de Capelongue (B,D)

Day 5: Luberon / Avignon

This morning's cooking lesson will focus on baking bread and traditional Provençal dishes. Sit down for a picnic and treat your palate to a delicous lunch with perfectly paired local wines. Head to the historic center of Avignon, a UNESCO World Heritage Site. The Palais des Papes, noted for its medieval Gothic architecture, was the residence of the popes for much of the 14th century. Beneath it, the Petit Palais and Romanesque Cathedral of Notre-Dame-des-Doms are further demonstration of the papal influence. The 12th-century St. Benezet Bridge, made famous by the French children's song "Sur le Pont d'Avignon," provides beautiful views over the Rhône. Continue to Barthelasse Island to learn about the art of distilling and taste unique brandies and liqueurs. Overnight: at Domaine de Capelongue (B,L,D)

Day 6: Les Baux / Saint-Rémy

World renowned for its location on the rocky plateau in the heart of the Alpilles and with panoramic view of Arles and the Camargue, Les Baux is a perfect stop for guided sightseeing. Explore the ruins of the original fortified town, dating back as far as 6,000 BC. Travel to Saint-Rémy for lunch on your own and to explore scenes that inspired Vincent Van Gogh. Visit some of his haunts and view the elements that influenced some of his masterpieces.

Overnight: Domaine de Capelongue (B,L)

Day 7: Lourmarin

Enjoy a chef-guided stroll through Lourmarin Market to discover local ingredients and their culinary qualities. Explore Chateau de Lourmarin, the first renaissance castle built in Provence and said to be the most beautiful in France. Wander through the village market before returning to Domaine de Capelongue to enjoy the property. Relax, stroll the beautiful grounds, take a dip in the pool, or walk to Bonnieux to explore. Overnight: Domaine de Capelongue (B,L,D)

Day 8: Aix-in-Provence

Known for its abundant markets of flowers, fruits, vegetables, and handmade crafts, Aix-en-Provence is the perfect spot for meandering. After your own exploration of the town's markets, rejoin the group and visit Cezanne's studio, where his materials remain just as he left them. A festive farewell dinner marks the end of a fabulous week.

Overnight: Domaine de Capelongue (B,D)

Day 9: Depart Marseille

After breakfast this morning, transfer to the airport for your return flight home or to the train station for guests who reserved an extended journey to Paris. (B)
